# **Types of Student Registry**

High School Students apply right out of high school with a minimum of 70% average and are required to meet the additional requirements listed on U of R website

University or College Applicants who have attended another recognized university or college to be considered for admission on the basis of post-secondary studies, applicants must have attempted 24 credit hours or more of approved post-secondary courses with a minimum UGPA of 60%. Students who have completed less than the required number of credits at the post-secondary level will be admitted based on high school admission criteria and must provide an official high school transcript, unless they are over 21 years of age and qualify for Mature Admission.

Mature Admission may be granted to applicants for admission who have completed fewer than 24 credit hours of approved post-secondary courses, are Canadian citizens or permanent residents, and will be at least 21 years of age before the term begins.

# **Program Overview**

The Indigenous Birth Support Worker Certificate Program (IBWC) is an 18-credit program that would primarily be offered at the Northern Campus, Prince Albert. Students must complete the Doula Certificate program and an in-community practicum working with birthing families.

Graduates of the program would attain skills in community education, family and social dynamics, cultural birthing customs and practices, and health practices. They would be able to provide workshops and teaching circles on various topics to the community and allied professionals.

The Indigenous Birth Support Workers would have the primary skill to educate and assist licensed midwives and family physicians on land-based birthing, pre-birthing, and aftercare as part of their primary care practice. Workers will assist communities in revitalizing Indigenous pre- and post-birthing practices in First Nations communities.

# **Program Requirements**

#### **Indigenous Birth Support Worker courses:**

- INHS 100 Introduction to Indigenous Health Studies I (3 credits)
- INHS 140 Introduction to Community Birthing Education (3 credits)
- INHS 145 Introduction to Birth Practices (3 credits)
  - includes DONA Certificate training
- INHS 149 Birth Practices in the Community (6 credits)
- INHS 200 Traditional Indigenous Health Concepts (3 credits)

# **Admission Requirements**

#### **Prospective Students**

This program invites Community Health Representatives and Community Family Support Workers to increase their scope of practice to include Indigenous Birthing support.

Students can apply for the Indigenous Birth Support Worker Certificate through the Indigenous Health Program, First Nations University of Canada.

Students must also provide an updated Criminal Record Check dated within the last 6 months upon registration. A clean criminal record check is not required for admission.
